



## Thermo-laminated Profile Doors and Panels 7 Year Limited Residential Warranty

Note: This warranty document should be read in conjunction with the SmartStyle Thermo-laminated Doors and Panels Care and Maintenance Guide to provide a full understanding of warranty conditions.

All HVG Decorative Building Products (referred to as HVGB within this document) SmartStyle thermo-laminated products are manufactured from the highest quality materials and designed to provide years of trouble-free service. HVGB warrants that its SmartStyle thermo-laminated doors and panels shall be free from defect for a period of seven (7) years from the date of manufacture.

HVGB warrants that, under normal use and service, the material and workmanship of its SmartStyle thermo-laminated products shall conform to the standards on the applicable technical data sheet for a period of seven (7) years from the date of manufacture.

In the event that a HVGB SmartStyle thermo-laminated product does not perform as warranted, the first purchaser's sole remedy shall be limited to repair or replacement of all or any part of the product, which is defective, at HVGB Decorative Building Products' sole discretion.

This warranty applies only to thermo-laminated product:

- 1. In its original installation; and
- 2. Purchased by the first consumer purchaser.

This warranty shall not apply to defects or damage arising from any of the following:

1. Accidents, abuse, or misuse;

2. Exposure to extreme temperature or humidity, whether it be environmental or produced (ie; steam and heat from cooking);

3. Improper fabrication or installation, including not using appropriate clearances or heat deflectors where required; or

4. Improper maintenance.

No other warranties, express or implied, are made. Under no circumstances shall HVGB be liable for any loss or damage arising from the purchase, use, or inability to use this product, or for any special, indirect, incidental, or consequential damages. No fabricator, installer, dealer, agent, or employee of HVGB or its parent/partner companies has the authority to modify the obligations or limitation of this warranty.
